Dear Ms Dortch:

In accordance with 47 CFR 73.561 (d), Minnesota Public Radio ("MPR"), licensee of KCCM, Moorhead, MN, hereby notifies the Commission that KCCM has recently been operating at approximately 30% of its authorized power.

KCCM is operating at 30% power due to transmitter failure. Parts are on order for the repairs, but the manufacturer is currently out of stock. MPR is working diligently to effect repairs as quickly as possible and hopes to have the station back up to full power soon.

MPR is a noncommercial educational licensee; therefore, no fee is required for this filing.
