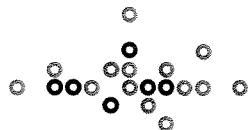

On December 2, 2009, in accordance with 47 CFR 73.561 (d), Minnesota Public Radio ("MPR"), licensee of KCRB-FM, Bemidji, MN, informed the Commission that as of November 24, 2009 KCRB was operating at about 71% of its authorized power. A copy of that letter is attached.

MPR is pleased to report that as of December 16th, KCRB-FM is back up to its fully authorized power.

An Anti-Drug Abuse Act certification form is attached. MPR is a noncommercial educational licensee, therefore, no fee is required for this filing.

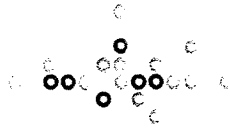

Dear Ms Dortch:

In accordance with 47 CFR 73.561 (d), Minnesota Public Radio ("MPR"), licensee of KCRB-FM, Bemidji, MN, hereby informs the Commission that as of November 24, 2009 KCRB began operating at about 71% of its authorized power. The cause of the problem is a broken blower motor. Part and repairs of the motor are anticipated to take more than 10 days.

All reasonable efforts will be made to replace the damaged equipment and get the station back up to its authorized full power as soon as possible.
