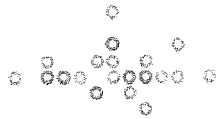

Notice of temporary reduction of operations

Dear Ms Dortch:

In accordance with 47 CFR 73.561 (d), Minnesota Public Radio ("MPR"), licensee of KLNI-FM, Decorah, Iowa, hereby informs the Commission that KLNI has been operating at about 60% of its authorized power since July 22, 2010 and is expected to be operating at reduced power for a bit longer. Storms caused damage to the antenna system and to the main transmitter of the facility.

The antenna damage has been repaired, but the main transmitter damage is still in the process of being repaired. All reasonable efforts will be made to replace the damaged equipment and get the station back up to its authorized power as soon as possible.

An Anti-Drug Abuse Act certification form is attached. MPR is a noncommercial educational licensee, therefore, no fee is required for this filing.
