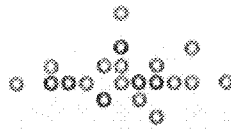

In accordance with 47 CFR 73.561 (d), Minnesota Public Radio ("MPR"), licensee of KLNI, Decorah, IA, hereby notifies the Commission that KLNI has been operating at approximately 65% of its authorized power since March 12, 2012.

KLNI is operating at reduced power due transmitter damage from a power failure. MPR is working diligently to make the needed repairs as quickly as possible and hopes to have the station back up to full power soon.
