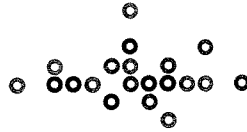

Minnesota Public Radio ("MPR") recently became the licensee of K247BF. The prior licensee, Horizon Christian Fellowship, filed the attached FCC Notification of Suspension of Operations/Request for Silent STA with the Commission on May 30, 2008.

Since that date, the license was assigned to Minnesota Public Radio. On August 26, 2008, this facility went back air, rebroadcasting the signal of KLNI (FM), Decorah, IA.

An Anti-Drug Abuse Act certification form is attached. MPR is a noncommercial educational licensee, therefore, no fee is required for this filing.

THE UNDERLYING UNDERSTANDING WITH MPR WAS REACHED SOME WEEKS AGO AND A DEFINITIVE ASSET PURCHASE AGREEMENT IS BEING COMPLETED. IN ANTICIPATION OF THIS SALE TO MPR, HCF REMOVED THE TRANSLATOR FROM SERVICE IN ORDER TO CONSERVE FINANCIAL RESOURCES. UPON APPROVAL OF THE ANTICIPATED ASSIGNMENT, SERVICE WILL BE RESTORED BY MPR.


**Anti-Drug Abuse Act Certification**


