

By letter filed with the Commission on June 29, 2005, Minnesota Public Radio ("MPR"), permittee of K264AR, Roseau, MN, hereby requested Special Temporary Authority to operate at reduced power due to a problem not with K264AR, but with the equipment of another communications tenant on the tower that is co-located with K264AR. Notice of Temporary Reduction of Operating Power


Dear Ms Dortch:

On behalf of Minnesota Public Radio ("MPR"), permittee of K264AR, Roseau, MN, this is to notify the Commission that K264AR is temporarily operating at reduced power due to a problem not with K264AR, but the equipment of another communications tenant that is co-located with K264AR. The other tower tenant is in the process of resolving its issue, and MPR is operating the translator at reduced power to accommodate the other tenant. MPR expects to return the translator to its authorized power shortly.

MPR is operating K264AR pursuant to program test authority. An application for a license to cover the construction permit for the facility, BLFT-20050609ABU, is pending.
