The purpose of this letter is to advise the Commission that KZSE does not operate under a main studio waiver. MPR maintains a fully staffed Main Studio for KZSE.

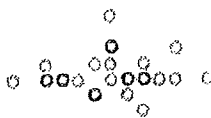
