On August 16, 2011, Minnesota Public Radio ("MPR"), the licensee of WIRN (FM), Buhl, MN, pursuant to Section 73.156(d) of the Commission's rules, notified the Commission that the station was operating at reduced power (copy attached). On September 7, 2011, MPR requested a Special Temporary Authority to continue to operate WIRN (FM) at reduced power (copy attached). The STA was granted on September 19, 2011.

WIRN (FM) is now back up to full power. Therefore, the STA is no longer necessary.

Dear Ms Dortch:

In accordance with 47 CFR 73.561 (d), Minnesota Public Radio ("MPR"), licensee of WIRN-FM, Buhl, MN, hereby informs the Commission that WIRN has been operating at about 50% of normal operations since August 4, 2011. We expect WIRN to be operating at reduced power for at least a few weeks due to transmitter problems. All reasonable efforts will be made to repair the faulty transmitter and get the station back up to its authorized power as soon as possible.

An Anti-Drug Abuse Act certification form is attached. MPR is a noncommercial educational licensee, therefore, no fee is required for this filing.

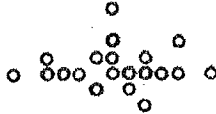

Pursuant to 47 CFR 73.1635, Minnesota Public Radio ("MPR"), licensee of WIRN, Buhl, MN, hereby requests Special Temporary Authority to operate WIRN at reduced power.

In a letter dated August 15, 2011 (copy attached), MPR notified the Commission that WIRN has been operating at approximately 50% of its authorized power since August 4, 2011.

The intermediate power amplifier in the transmitter has failed. The amplifier has been sent in to the manufacturer for repairs. MPR is working diligently to make the needed repairs quickly and have the station back up to full power as soon as possible.

MPR is a noncommercial educational licensee. Therefore, no fee is required for this filing.
