Dear Ms Dortch:

Minnesota Public Radio (MPR), the licensee of WMLS, was recently advised by the owner of the tower on which the station is placed that the Antenna Structure Registration (ASR) for the tower was recently changed by the Commission. The tower owner added some height to the top of the tower, which does not affect WMLS, but in doing so a different ASR number was assigned to the tower.

The current license for WMLS states that the tower the station is on is ASR #1061466. Attached to this letter is a copy of the new ASR, which is ASR #1259981. There are no other changes to the WMLS license.
